

Financial Disclosure Statements

The following tables show compliance with filing Financial Disclosure Statements for CY 2018 by agency, boards and commissions. The Office of Ethics and Accountability processed over 1,100 Financial Disclosure Statements during the FY 2019 as designated filers must file disclosures for the previous calendar year.

Financial Disclosure Statement Exemptions and Waivers

During fiscal year 2019, the Board of Ethics did not receive any requests for exemptions or waivers regarding the filing of Financial Disclosure Statements (FDS) by designated employees and officials.

Financial Disclosure Statement Late Fee Waiver Requests

Financial Disclosure Statements are due on April 30 of each calendar year. If an individual fails to submit their completed form to the Office of Ethics and Accountability by the April 30, deadline, they are subject to a late fee at the rate of \$2.00 per day up to a maximum of \$250.00 in accordance with Section 2-292 of the County's Ethics Code. The requests were discussed confidentially in closed sessions of the Board of Ethics meetings. The Board of Ethics has delegated the review of late fees waivers to the Office of Ethics and Accountability and appeals of denials are provided to the Board of Ethics for determination. There were eleven (11) requests to waive late fees received related to the filing of the calendar year 2018 Financial Disclosure Statements.
