ADMINISTRATIVE MATTERS

- 1. Call to Order The Chair called the meeting to order at 5:35 pm.
- 2. Adopt Agenda Commissioner Bryant– Motion to adopt the agenda; Commissioner Price-Carter– Seconded the Motion. By unanimous vote, the agenda was adopted as written.
- 3. Approval of Minutes of the **March 22, 2021** meeting. Commissioner Johnson– Motion to adopt to minutes of the March 22 meeting. Commissioner Price-Carter Seconded the Motion. By unanimous vote, the minutes were adopted.

4. REPORT OF THE CHAIRPERSON

The Chair welcomed everyone and reminded the Commissioners that financial disclosure forms are due April 30th for anyone who hasn't yet completed. She noted that the Executive Director would be offering updates on Division 12. The Executive Committee

met to review by-laws and will have another meeting tomorrow. When by-laws are updated they will send to full Commission as well as Executive Director for review. She thanked the Commission for all of their efforts and their team.

She announced that she will not be seeking re-appointment as Chair of the Commission and that the June meeting will be her last Commission meeting. She thanked former County Executive Rushern Baker for appointing her and thanked County Executive Alsobrooks for appointing her Chair. She has been honored and grateful to have served alongside all of the Commissioners.

5. REPORT OF THE EXECUTIVE DIRECTOR

The Executive Director reminded the Commissioners that the Clerk had recently sent out event news about upcoming events and encouraged Commissioners to check the Commission's webpage to see upcoming as well as previously held events. She provided information about CB-11 – the Executive order that separates our office from the Office of Community Relations, taking us back to how our agency stood from 1972 to 2011. CB-12-2021 is the updated version of Division 12 which will take effect on October 1, 2021. The Office of Law also clarified functions of staff and commissioners. The only substantive changes were adding gender identity as a protected class and changing name to Office of Human Rights. She also noted that under housing division there were updates to protected classes. The Executive Director offered to send CB-11 and/or CB-12 out for any of the Commissioners who are interested. Discussion about updates and separation of agencies.

The Executive Director shared information about the Language Access Compliance Program, providing a detailed introduction to the act and the agency's program.
