Commissioner Seidel spoke on the subject area:

- MD Veterans Affairs Trust Fund 501(c):
 - https://veterans.maryland.gov/maryland-department-of-veterans-affairs-veterans-trust-fund/
 - It is a non-emergency temporary financial assistance program. Governed by a Board of Trustees.
 - Assist veterans in need but do not address chronic issues. The funds can be used for Mortgage, Rent or Utilities.
 - o Motto: "Hands up not a Hand Out".
 - The state donated a \$100k to the fund and \$0 goes toward the administration. (Mark Hendricks) He is a state employee and gets paid from the MD state. All funds go directly to the veterans, widows and widowers of veterans.
 - o In 2017, the program gave out \$99k. These are grants **not** loans.
 - There is an application process and the application review process approximately biweekly.

 - Go to the casinos and ask about the box that people can donate funds for veterans.
